Item 2: Matters Arising and Actions Report - (MA1) - PC reported that the problems of late postal deliveries had reduced but as was to be expected had not gone away. (A4) ABC Kennington North development - PC has obtained a file copy of the letter sent by Winston Michael. This has been circulated to all committee members and attached to the Minutes of the previous meeting for recording purposes

Item 3: Planning Issues - ABC Kennington North development -HP reported that another meeting of the Action Group had taken place and arrangements were in hand for a public meeting. Goat Lees School - HP informed members that the ownership of the relevant land had now passed to Kent County Council from the developers. Various Other Matters - HP updated members on the progress of the proposal for No7 Warren Lane - gone to appeal - 'Park and Ride' this is associated with the commenced revisions to M20 Junction 9 which is being funded by SEDA.
