Simon Cole, Planning Policy Manager ABC, to speak on 'Planning Policies Affecting North Ashford'.

## **Planning**

- Plans of development behind Molehill presented. Includes a private Health Centre and other commercial sites, although Bidwells had proposed housing. No access on to Sandyhurst Lane – will be on to Nicholas Road - means more traffic on Trinity Road
- Park and Ride ongoing. Plans included housing and gardens up to ancient hedge. SLRA suggested road between the two, to avoid dumping
- Plot between Simone Weil and Maidstone Road Cadenza put forward plans for housing. Pub now going on to plot by Cineworld (see below)
- Barracks site new part of application triggered new access on to Templar War and works at Drovers roundabout
- Link road originally proposed that housing off Ball Lane would pay for road. Road may not now happen
- Trinity Road not yet adopted. Affected by latest reorganisation at Highways number of staff left
- SLRA policy on planning applications policy is one of non-interference in applications by
  residents where there are no objections. If neighbours are unhappy, SLRA tries to mediate with
  involvement of borough councillor and planning officer. Examples of such disputes put forward
- New cinema David Porter objected on behalf of SLRA because of inadequate parking, and Howard spoke at Planning Committee meeting
- Costa Coffee being built at Cineworld plus Whitbread pub
- Carpenders proposed demolition and building 3 houses on lpot. SLRA objected and notified neighbours via flyers. Application withdrawn but new one submitted – still has 2.5 storey buildings
- 158 Sandyhurst Lane complaints that new front garden wall is dangerous and encroaches on road. Being investigated by Highways

  advice (eg for planning applications)
