Minutes of SLRA Committee meeting held at Sandyacres Clubhouse on Thursday, 13 January 2011.

# PETER COATSWORTH

The committee recorded a debt of gratitude to the late Peter Coatsworth who had diligently served the committee as Secretary. He was remembered with affection for his kindly nature and good humour.

Desmond Henley was welcomed to the meeting; he had been nominated by John Faulkner.

### Item 1: Minutes of the meeting held on 26 August 2010.

#### a) Approval

The Minutes were agreed and signed.

#### b) Matters Arising

There were no matters arising which were not covered elsewhere in the agenda.

#### Item 2: Planning Issues

HP gave a further report on a planning application (Footpath AE210) relating to Eureka Upper Pemberton. The construction of a car park had been permitted by the ABC Planning Committee on 15 September 2010 subject to the consequent diversion of AE210 being formally agreed by KCC.

HP also reported that, at the same meeting, the application to build a 4 bedroom house on land adjacent to 10 Sandyhurst Lane/Potters Close had been refused on the grounds of access and size. A new application had recently been submitted for a three bedroom house with access from Sandyhurst Lane, rather than Potters Close.

**HP** also drew attention to a recent application for a single storey rear extension to Two Chimneys, 28 Sandyhurst Lane.

## Item 3: Financial Statement

In the absence of the Treasurer, **HP** noted that there was about £121 in the Association's account and that a donation of £20 had been made to the Celia Blakey centre at the William Harvey Hospital in memory of the late John Kemp MBE, who died on 11 November 2010.

# Item 4: Communications

**DP** referred to the SLRA website which was now operational. The following items were agreed:
